## UNPRME PRINCIPLES-RELATED ACTIONS AND NOTED

### Principle 1. Purpose:

EUCLID took into account UN PRME as part of its own 10 year anniversary review as well as preparation of strategic goals for quality assurance agencies. UN PRME purposes were also integrated in development of online course dealing with UN sustainable development goals.

### Principle 2. Values:

As part of its global entrepreneurship initiatives and training, EUCLID validated the possible plans taking into account UN PRME values. During the significant revision of the EUCLID LMS platform, UN PRME links were reviewed and kept in a prominent place to ensure that all students have easy access and reminders to UN PRME documents.

### Principle 3. Method:

UN PRME was referred to as part of our methodology checklist when imagine projects and evaluating initiatives. This was a particular case when evaluating and developing financing and support for a global enterprise called SwissCorps.

Guided by UN PRME principles, EUCLID has developed further partnerships within the UN PRME framework including with:

- Africa leather and leather product Institute
- AUAP (Association of the Universities of Asia and the Pacific)
- IPAG (French private business school)

## Principle 6. Dialogue

Between 2016-2018, EUCLID has organized several events related to interfaith dialogue. EUCLID also facilitated the creation of a network of mayors and cities for interfaith harmony.

## PART II: DESCRIPTION OF ACTIONS related to both UN academic Impact and UN PRME

During the period covered (2016-2018), EUCLID continue to integrate global compact concepts in its activities and curriculum. A specific course (code UN-SDG) dealing with the UN sustainable development goals was developed which also covered global compact essential knowledge.

In compliance with the logo use guidelines, EUCLID has continued to raise awareness about the UN global compact values and network whenever possible, especially in regions/countries where knowledge of the global compact is limited (Central African Republic, Gambia for instance).

EUCLID has initiated the possible creation of a national UN global compact network hosted at its office located Avenue to France in Bangui (for the Central African Republic).

In planning development for 2018 2020, notably developments in business projects (including entrepreneurship entities), UN global compact principles were reviewed and taken into account.
